- Plan choices at BVCC are *Simple and Straightforward!!*
- You can choose between an individual pre-paid plan or a fixed price plan.
- The Individual plan is designed for the golfer that enjoys playing golf multiple times per week during a majority of the season. Purchase this plan and your green fee and powered cart rental is pre-paid each time that you play.
- Updated for 2023 is the 35/49 Seasonal plan. This plan is well suited for any golfer not sure if he or she can commit to a heavy golf play schedule, but enjoys playing somewhat frequently. After making a nominal upfront purchase, the planholder is required to pay \$35 (weekdays) or \$49 (weekends) for each round of golf that he or she plays during the season of the 2023 GFCRD term. However, in the off-season, the price to play is \$33 (weekdays) or \$44 (weekends).
- BVCC offers the USGA GHIN Handicap Computation Service*. The Active Season in NJ is from April 1 through November 14, each year. Shortly before the beginning of the 2023 Active Season, the Handicap Computation Applications will be made available.
- Although a GFCRD Plan Term runs from 3/1/23 to 2/29/24, you can begin playing golf as a Planholder as soon as we receive your completed application and payment.
- Buena Vista has practice facilities that can help you improve your game. Both the grass driving range and large practice putting green are accessible.

*Days Definition: Natural Weekend Days (Saturday & Sunday), as well as the Designated Holidays listed above are considered Weekend Days for purposes of determining golf course availability and pricing. All other days shall be considered Weekday Days.

III. TERMS & AGREEMENT

All 2023 GFCRD Plans are valid with a term defined from date of purchase until February 29, 2024. Buena Vista Country Club retains the right to revoke GFCRD Plan rights if Planholder violates any of the agreed rules and regulations as stated on the application form and found elsewhere at the Buena Vista Country Club property as well as its website.

It is understood that the golf course will be open and available nearly everyday of the calendar year with the exception of December 25 and possibly Thanksgiving Day. From time to time, weather conditions will present circumstances that will require the closure of the golf course. This may come in the form of heavy sustained rain as well as the aftermath of wind damage making it unsafe to enter the golf course. Buena Vista will endeavor to re-open the golf course as quickly as possible under these weather related circumstances.

Additionally, Buena Vista CC may be forced to close the golf course by a third party, such as a governmental regulation or order involving a public health safety concern.

In the event that the duration of a golf course closure becomes excessively long, it is understood that Buena Vista CC will have sole discretion over any remedy and whether a remedy is warranted.

By signing this agreement, you acknowledge complete understanding of the plan that you have chosen and hereby agree to abide by The Rules of the United States Golf Association and The Buena Vista Country Club Rules & Regulations (subject to modification from time to time as the Club deems necessary). It is also understood that any GFCRD Plan, once purchased, is non-transferable. Cancellation/Revocation and any respective refund will be determined at the sole discretion of the Club. Once you have submitted a signed application, along with correct payment, your GFCRD Plan will become effective and expire as stated herein.

2023 RULES & REGULATIONS

Facility or Club	: <i>References to Buena Vista Country Club, its property and/or amenities that it offers.</i>
Mandatory Foursome Rule	: <i>Starting time reservations must be made for four golfers. Payment obligation must be rendered for all four golfers. If less than the four reserved starting times are committed, the starting time for the group may be delayed or fortified with other available golfers.</i>
Starting Time Policy	: <i>Upon committing to a starting time reservation, the individual(s) reserving the starting time is responsible for all Unpaid Reserved Starting Time Green Fees and the appropriate number of Powered Golf Cart Rentals.</i>
The Mandatory Cart Rule	: <i>Singles or Twosomes are required to rent One Powered Golf Cart; Threesomes or Foursomes are required to rent Two Powered Golf Carts.</i>
Cart Rental Limitations	: <i>No more than one cart may be rented for any two golfers. If applicable, both occupants must acknowledge & sign for cart rental. Golf cart drivers must have and may be requested to present a valid motor vehicle driver's license.</i>
Walking ILO Cart Rule	: <i>A special Trail Fee is available when carts are mandatory that allows the golfer the ability to walk ILO renting a Powered Golf Cart. You Must Check with Club Management to verify if this rule is in effect.</i>

- All golfers may make a Starting Time Reservation at least 10 days prior to respective date. A Planholder has the right to reserve, one round of golf per day, based on current availability regardless of individual who reserves the aforementioned round of golf.
- All GFCRD Plans, except the 35/49 Seasonal Plan, entitle the planholder to one non-paid round of golf per day. If Planholder desires to play an additional non-paid round of golf on the same day, approval from Club Management is necessary.
- Planholders playing in any Outing/Tournaments must pay the published Green Fee and Cart Rental.
- Planholders may be required to provide and maintain a valid credit card, on file, to be used for collection of delinquent financial obligations.
- Any Planholder that incurs Green Fee and/or Cart Rental charges because of "No Shows" and does not take care of his/her financial obligation will force his/her GFCRD Plan to be placed under review and risks suspension or cancellation of his/her GFCRD Plan.
- The Mandatory Foursome Rule may be put into effect from time to time as Club Management deems appropriate.
- No fivesomes are allowed without advanced notice to and authorization from Club Management; advanced notice is only required during the months of May, June, July, August, and September, however, authorization from Club Management is still required.
- The Mandatory Cart Rule is in effect on Weekend Days¹ until 1:00 pm from April 1, 2023 until October 31, 2023; and on Weekday Days¹ until 11:00 am from May 1, 2023 until September 30, 2023.
- Plan Options which include cart rentals afford the Planholder an option to pre-pay for cart rentals but do not relieve Planholder of any policies, rules, and/or regulations which govern cart rentals.
- Planholders may be issued a Planholder Card and may be required to present it along with a form of identification at the Golf Shop Desk prior to Starting Time. If required, and a Planholder Card is not presented, a Green Fee and/or Cart Rental will be charged.
- Under certain weather conditions, golf carts may be required to remain on the cart path. This Cart Paths Only rule may be in effect for any part of the golf course. All golfers are expected to adhere to this rule and leave the golf cart on an appropriate cart path, when in effect.
- A person must be at least 8 years old to ride in a powered golf cart. A person may only drive a powered golf cart with a valid driver's license.
- A golfer must be at least 6 years old to play golf at the Club. Additionally, a golfer younger than 13 years old is required to do so with adult supervision.
- Food, alcoholic or non-alcoholic beverages (with the exception of bottled water), coolers or cooler-like containers are not permitted to be brought onto the Facility unless prior arrangements have been made with Club Management.
- Under all circumstances, strict attention must be given to Club personnel, specifically The Ranger. If resistance is encountered you will be requested to leave; and if you do not comply, you will be escorted from the Facility premises by local and/or state police.
- Any misconduct with respect to behavior while on the premises of the golf course that results in a police action or any type of altercation with other golfers, patrons of the Club, and/or Club personnel will result in an automatic suspension of GFCRD Plan and upon further review may result in termination of GFCRD Plan without any remuneration.
